Pension Contributions Transmittal Agreement  
For Calendar Year 2017**

Local \_\_\_\_\_ of the American Federation of Musicians (the "Local") hereby agrees when accepting checks for pension contributions payable to the American Federation of Musicians and Employer's Pension Fund (the "Fund"), to be bound by, the Fund's written Pension Contributions Transmittal Procedures dated June 1, 2004 (the "Procedures").

The Local acknowledges that the Fund may terminate the Local's authority to collect pension contributions with or without advance notice to the Local, upon the failure of its employees responsible for receiving or handling pension contributions due to the Fund and for delivering those pension contributions to the Fund to comply with the Procedures at all times. Additionally, the Local understands that the Local will be responsible for late payment interest charges that may accrue on payments that are not remitted promptly to the Fund. If the Local holds checks for more than 14 days following receipt from the employer without notifying the Fund or without a valid reason (as determined by the Fund), misplaces checks, or loses checks before mailing them to the Fund Office, the Local will be responsible for the payment of late payment interest charges from the date the payment was received at the Local office to the date the payment is actually received by the Fund.

The Local understands and agrees that the Fund has the right to perform an audit at the Local to verify that the Procedures are being followed correctly. Such audit may be conducted with or without prior notice to the Local.
